**BY-LAW NO. 8019-2006**

**A BY-LAW TO APPOINT AN ACTING MAYOR FOR EACH MONTH  
OF THE CURRENT TERM OF COUNCIL (2006-2010)**

WHEREAS pursuant to section 242 of the Municipal Act, Chapter M.45, R.S.O. 2001, the Council of any municipality may by by-law or resolution appoint a member of the council to act in the place of the head of council when the Head of Council is absent or refuses to act or the office is vacant and while so acting, such member has all the powers and duties of the Head of Council;

AND WHEREAS By-law 7852-2004, being the Procedural By-law for the Town of Smiths Falls, provides for the appointment of Acting Mayors;

NOW THEREFORE the Municipal Council of the Corporation of the Town of Smiths Falls enacts as follows:

1. The named Members of Council shall appointed Acting Mayor for the month and year indicated on the attached Schedule "A".
2. In the absence of the Mayor, the Acting Mayor shall have all the powers and duties of the Head of Council during the term indicated.
3. Should the named Member of Council be unable to perform the required duties, the Councillor who is named in the immediately previous month, shall be deemed to be Acting Mayor.
4. That the provisions of this by-law shall come into force and take effect upon the passing thereof.
