TAKE NOTICE that the Secretary-Treasurer of the Planning Advisory Committee will issue a revised Notice of Public Meeting upon rescheduling. The "purpose and effect" of the consent application, as described below, may be subject to change during the rescheduling of the Public Meeting.

PURPOSE AND EFFECT: The purpose of application B23-03 is to facilitate a lot line adjustment between the properties municipally known as 7 Maple Avenue North and 11 William Street West. Application B23-03 proposes to sever a 0.3 m X 16 m (4.8 m²) parcel of land along the eastern property line of 11 William Street West to be added to the property at 7 Maple Avenue North. The lot line adjustment is requested to accommodate an additional two (2) parking spaces for the development at 7 Maple Avenue North and ensure the development complies with the required number of parking spaces in accordance with the Town's Zoning By-law.

Both the subject property and the receiving property are zoned Downtown Core under the Town's Zoning By-law 10375-2022 and designated Downtown Core in the Town's Official Plan. The Zoning By-law permits a mixed-use development dwelling in the Downtown Core.
