PURPOSE AND EFFECT: The purpose of Consent Application B24-01 is to sever a 903 m² (9719.8 ft²) vacant parcel from the property municipally known as 241 Brockville Street. The parcel to be retained is 1,333 m² (14348.3 ft²) in size and contains a single-detached residential dwelling. The severed parcel is proposed to remain for residential use; however, no development concept has been finalized. No change of use or additional development is proposed for the retained parcel.

The subject property is designated Residential in accordance with the Town's Official Plan. The subject property is zoned Residential Type 2 (R2)
