1. THE LOCATION OF THE UTILITIES IS APPROXIMATE ONLY. THE EXACT LOCATION SHOULD BE DETERMINED BY CONSULTING THE MUNICIPAL AUTHORITIES AND UTILITY COMPANIES CONCERNED. THE CONTRACTOR SHALL PROVE THE LOCATION OF UTILITIES AND SHALL BE RESPONSIBLE FOR ADEQUATE PROTECTION FROM DAMAGE.
2. ALL DIMENSIONS ARE IN METRES UNLESS OTHERWISE NOTED
3. ONTARIO PROVINCIAL STANDARD DRAWINGS (OPSD) & STANDARD SPECIFICATIONS (OPSS) SHALL APPLY TO THIS CONTRACT.
4. THE CONTRACTOR SHALL VERIFY AND LOCATE ALL EXISTING STORM AND SANITARY SERVICES IN THE FIELD AS DIRECTED BY THE CONTRACT ADMINISTRATOR.
5. ALL BASE MAPPING IS REFERENCED TO NORTH AMERICAN DATUM OF 1983 (NAD83).

SEWER NOTES:

1. THE CONTRACTOR SHALL REMOVE AND DISPOSE OF EXISTING SANITARY SEWERS AND MAINTENANCE HOLES, INCLUDING MAINTAINING AND MANAGING EXISTING SEWER FLOWS DURING THE PERIOD OF CONSTRUCTION, AS SHOWN ON CONTRACT DRAWINGS. NO ADDITIONAL CLAIM SHALL BE ALLOWED FOR THIS WORK AND SHALL BE DEEMED TO BE INCLUDED IN THE BID UNIT PRICE TO CONSTRUCT THE PROPOSED SEWERS.

WATERMAIN NOTES:

1. THE CONTRACTOR SHALL BE RESPONSIBLE TO DETERMINE VIA EXCAVATION THE EXACT LOCATION, ELEVATION AND SIZE OF THE EXISTING WATERMANS AS REQUIRED FOR ALL CONNECTIONS, RELOCATIONS AND BLANKINGS.
2. THE CONTRACTOR IS RESPONSIBLE FOR PROVIDING PROTECTION FOR ALL EXISTING UNDERGROUND UTILITIES DURING CONSTRUCTION.
