## **8. BUSINESS ARISING FROM THE PREVIOUS MEETING**

### **a) 2025 Budget Monitor – Chief**

Received the budget monitor this morning from Treasurer Dowber. Above on maintenance, repairs (property and vehicle), part time and overtime budget. Under budget overall. Some things are unpredictable (repairs). For 2026 ensured that cost of living was added.



b) 2026 Budget & Capital- Chief

No questions from Council. Awaiting final approval. Does not anticipate any issues. 3% increase. Lowest in province budget wise for this year. Budget includes part time going to fulltime.

## 7. NEW BUSINESS

a) Building Costs/ Insurance Inspection – Vice- Chair

R Dopson noted the inspection was not bad considering building. \$318,000 contributed to Police budget for a Town building. Questioned if there should be a lease. The Act notes that the force is to be supplied with a building.

J Empey noted that there is a manager that looks after all the buildings. This has been a big help, but he is very busy. All departments seem to have an individual budget. Town short on cleaning staff.

S Pankow questioned why there were two interest loans. J Empey to look into and advise.

b) Grant Update- Chief

RIDE Grant- \$11,377 per year- total funding for 4 years (2025-2029) \$45,508.

NG 911 Grant- Total funding \$156, 894 – IT portion was \$116,725

\$8,000 for CISCO membership grant- supports the cost of a leased vehicle for the service for CISCO related projects.

c) Strategic Plan- Chief

Fourth year students from Queen's University reached out regarding our Strategic Plan. J Empey reached out to the Professor. They have done a Strategic Plan for Gananoque. The Strategic Plan needs to reflect the new Act. The Professor noted that the students could start in May. Interview Chief and Board Chair. They look after surveys, consultations, etc. There is a fee - \$5000 to \$5500 to complete. Consultants would be much higher. Would be a positive thing to have for the service. There would be a contract. Will touch base with group in April. J Empey to distribute Strategic Plan for Gananoque when complete.

- d) Increase in taxi licenses through town bylaw

Looking at increasing some fees. Did a survey to see what others are charging. Need to look at other ride sharing options as well. Bylaw is antiquated. Police do not make the changes to the bylaw. Need to have full cost recovery.

Broad Criminal Records Checks are requested and \$40 is currently being charged for extensive background checks. Looking to increase this to cover the costs. J Empey noted that fees were raised last year for criminal records checks. Free for volunteers. Recommends \$80 for the Broad Criminal Records check. Fingerprinting fee to remain status quo.

- ONE WOMAN HAS BEEN CHARGED AFTER A FIVE-MONTH MULTI-JURISDICTIONAL INVESTIGATION INTO AN EMAIL SCAM THAT DEFRAUDED A LOCAL BUSINESS OUT OF MORE THAN \$255,000.
- ON MONDAY, MAY 5, 2025, A CALGARY-BASED OIL FIELD SUPPLY COMPANY REPORTED THEY HAD BEEN DEFRAUDED OF MORE THAN \$255,000 AFTER THEY DISCOVERED A PAYMENT THE COMPANY SENT HAD BEEN INTERCEPTED.
- INVESTIGATORS BELIEVE THE COMPANY'S EMAIL HAD BEEN INFILTRATED AND A LEGITIMATE INVOICE WAS SUBTLY ALTERED. AS A RESULT, THEIR EMAIL WAS INTERCEPTED, AND THE PAYMENT WAS REDIRECTED TO A FRAUDULENT BANK ACCOUNT.
- UPON FURTHER INVESTIGATION, THE FRAUDULENT BANK ACCOUNT WAS DISCOVERED, WHERE OFFICERS ALSO DISCOVERED AN ADDITIONAL DEPOSIT OF \$10,000 FRAUDULENTLY OBTAINED FROM THE CANADA REVENUE AGENCY (CRA).
- ON THURSDAY, OCT. 9, 2025, WITH THE HELP OF THE EDMONTON POLICE SERVICE, FOUR WARRANTS WERE EXECUTED IN EDMONTON AND CASH AND SEVERAL ITEMS WERE SEIZED INCLUDING:
  - \$17,830 CAD / \$1,414 USD / 10 DIGITAL DEVICES
- INVESTIGATORS WORKED CLOSELY WITH PARTNERS AND THE FINANCIAL INSTITUTION WHERE THE STOLEN FUNDS HAD BEEN FRAUDULENTLY TRANSFERRED, SUCCESSFULLY RECOVERING AND RETURNING THE FULL \$265,000 TO THE COMPANY AND THE CRA.
- ONE WOMAN HAS NOW BEEN CHARGED.
- ROSSWIDA TJIUEZA, 38, OF EDMONTON, ALTA., HAS BEEN CHARGED WITH TWO COUNTS OF FRAUD OVER \$5,000 AND TWO COUNTS OF PROCEEDS OF CRIME OVER \$5,000.
- SHE WILL NEXT APPEAR IN COURT IN EDMONTON ON FRIDAY, NOV. 14, 2025.
- “CYBER FRAUD INVESTIGATIONS ARE OFTEN HIGHLY COMPLEX, INVOLVING MULTIPLE JURISDICTIONS, DIGITAL FORENSICS, AND COORDINATED LAW ENFORCEMENT EFFORTS,” SAYS DISTRICT 2 INSP. KEITH HURLEY. “THIS FRAUD UNDERSCORES HOW SOPHISTICATED CYBERCRIMINALS CAN EXPLOIT BUSINESS COMMUNICATIONS TO REDIRECT SUBSTANTIAL FUNDS WITHOUT IMMEDIATE DETECTION.”
- “CYBERCRIME DOESN’T STOP AT JURISDICTIONAL BOUNDARIES, WHICH IS WHY LAW ENFORCEMENT AGENCIES WORK CLOSELY TOGETHER TO FIND AND CHARGE THOSE RESPONSIBLE, REGARDLESS OF WHERE THE CRIME IS COMMITTED,” SAYS DET. BRYAN MACAULAY, WITH THE EDMONTON POLICE SERVICE’S INVESTIGATIVE RESPONSE TEAM.
- INVESTIGATORS WOULD LIKE TO THANK SEVERAL PARTNER AGENCIES WHO PROVIDED CRITICAL SUPPORT TO THIS INVESTIGATION, INCLUDING FINTRAC, THE EDMONTON POLICE SERVICE, CRIME STOPPERS, AND SERVICE ALBERTA-SPECIAL INVESTIGATIONS UNIT, **SMITH FALLS POLICE SERVICE**, ONTARIO PROVINCIAL POLICE, LONDON POLICE SERVICE AND SURREY POLICE SERVICE.






